This Financial Services Guide (**FSG**) is provided by FORIS DAX AU PTY LTD (ACN 640 692 735) (**Crypto.com**, **we**, **our** or **us**) to you in relation to our activities (if any) which involve the provision of financial services as defined in the Corporations Act 2001 (Cth) (**Corporations Act**).

This FSG describes our services to assist you to decide whether to use them. It describes how we are remunerated, compensation arrangements, and how we handle any complaints you may have.

#### 1. Our Services

We are an authorised representative (AR No. 001286462) of FORIS GFS AUSTRALIA PTY LTD (AFSL No. 467462) (**Foris**), which has authorised the distribution of this FSG. Foris has authorised us to provide certain financial services in connection with Crypto.com Pay, a noncash payment facility issued by us (**Crypto.com Pay**). We offer Crypto.com Pay in Australia enabling customers to make payments to qualifying merchants both in Australia and overseas. Qualifying merchants are merchants who we determine, in our sole discretion to be able to be paid through Crypto.com Pay.

Foris is authorised, and has authorised us, to provide general financial product advice and deal in a financial product under its Australian financial services (AFS) licence in respect of:

(a) deposit and payment products including non-cash payment products;

Any financial product advice we provide will be general in nature and will not take into account your objectives, financial situation or needs. Because of this, before acting on any advice, you should consider its appropriateness having regard to your own circumstances,

Crypto.com and its related entities are also involved in the operation of a cryptocurrency exchange platform (**Platform**). The operation of the Platform does not itself constitute a financial service and is not covered by this FSG.

We and Foris act on your behalf when we provide the financial services described in this FSG to you.

## 3. How we are paid

None of us, our directors, employees or any of their associates charge for providing the financial services described in this FSG and neither do they receive any remuneration, commission or other benefits in respect of, or attributable to, those financial services. Crypto.com employees will receive a salary and may also receive other benefits based on their performance or the performance of Crypto.com.

Crypto.com and Foris are related bodies corporate.

Crypto.com does not receive any remuneration in connection with the distribution of Crypto.com Pay. Crypto.com has professional indemnity insurance in place that satisfies the requirements for compensation arrangements under section 912B of the Corporations Act 2001. This covers any financial services provided by us as an authorised representative of Foris.
